Please Read and Agree to the following:

Members planning on bringing **10 or more guests** **MUST** schedule a party through the manager. All after-hours and daytime parties should be scheduled at least one week prior to the requested date.

Daytime Party: Parties consisting of 10 or more guests or small parties desiring to use a pavilion must be reserved through the pool manager. The maximum number of participants **including** non-swimmers is **30**. The number of parties per day is restricted to one starting before 2:30 p.m. and one starting after 4:30 p.m. Each non-member guest fee is \$5. The party fee is \$40 which includes a pavilion and an extra guard to insure safety. The guard is **NOT** a party coordinator, but to be used for pool safety purposes **ONLY**. Parties are restricted to 2 hours. The party fee of \$40 will only be refunded should the pool close unexpectedly for reasons such as bad weather.

*** Note: Lily Flagg Board Members are required to pay the party fee of \$40, but are exempt paying non-member guest fees for up to 10 guests.

After Hours Parties: Parties for members that plan on bringing 30 or more guests including non-swimmers **MUST** schedule an after-hours party (after regularly scheduled pool hours). The party is restricted to 2 hours. Parties up to 60 guests are \$225 and parties of 60-80 guests is \$275. A **non-refundable** deposit is required at the time of the application of \$50. The balance is due at the time of the party along with the \$5 per non-member guest fees. The party fees are to cover lifeguards for safety purposes only. The lifeguards are **NOT** party coordinators. The pool management may refund the cost should the pool unexpectedly close for reasons such as bad weather.

The member host is responsible for guests' behavior and MUST be present until the last guest leaves the facility. It is the responsibility of the members and guests to remove food and beverage containers and dispose of them in proper containers. For large amounts of refuse, please use the green trash bins located near the clubhouse. Lily Flagg Club, Inc. assumes NO responsibility to members or guest for any accident or injury to person or property.
